

# NEW MEXICO STATE FAIR SCHOOL ARTS DISPLAY

## SEPTEMBER 8 – 27, 2010

The Student Art Display will be held at the State Fair Grounds from September 8 – 27, 2010. Please see that this information is made available to the individual who will bring the display so they are aware of the requirements. ### EXPENSE FEES

#### PLEASE GIVE A COPY OF THIS SECTION TO YOUR FISCAL REPRESENTATIVE

The fair pays a portion of the expenses for participating schools. The amount will be based on distance traveled by the school. Schools should provide travel reimbursement to personnel for time out of school on Wednesday, September 8<sup>th</sup> or Thursday, September 9<sup>th</sup>, 2010. The State Fair will pay mileage reimbursement for one round trip to each participating district at 44 cents per map mile.



### ELIGIBLE SCHOOL SYSTEMS

All schools systems (public, private, parochial or federal, grades K-12, which are approved by the New Mexico Public Education Department) can participate.

### ASSEMBLING AND DISMANTLING THE DISPLAY

Displays may be set up beginning at 8:00 A.M. until 5:00 P.M. on Wednesday, September 8<sup>th</sup> or Thursday September 9, 2010. Unfinished displays may be completed between 8:30 A.M. and 11:00 A.M. on Friday, September 10, 2010. The display may be taken down between 8:00 A.M. and Noon on Monday, September 27, 2010. All artwork needs to be removed from the display building by 12:00 noon on Monday, September 27, 2010.

### RESPONSIBILITY OF SCHOOL

School systems are responsible for bringing student artwork to the Fair, displaying it, and returning it after the Fair. Each item displayed should have an identifying label. Labels are on-line so you may make copies for your district. **You can choose to design your own labels.** All entries must be properly identified. List names for group projects on a separate sheet and attach to the display.

This display is an educational tool to share with the New Mexico community: i.e., parents, students, educators and other community members, to show increased student competence in meeting New Mexico Arts Standards, K-12.

## CRITERIA FOR DISPLAY

Display shall:

Present each student's work with the name of each student, media used, the student's teacher, school district, and grade.

Exhibit the work of individual students in drawing, painting, sculpture, folk arts/culture and other media which show that they have investigated ideas, materials, and have met the New Mexico Arts Standards.

Exhibit projects in which students worked individually or with others.

Exhibit artwork from all levels of the curriculum that meets or exceeds the standards through local, state and national frameworks.

Be well-planned and attractive with matted or framed artwork.

All student work should be well presented and protected. Please consider shrink-wrapping, laminating, matting, or framing to show and protect all work. The New Mexico Department of Education cannot take responsibility for damage due to weather or theft due to the openness of the display areas. If work is considered too valuable to display, please bring a picture or color-copy of it instead.



Please call about LARGE sculptures or student or group projects that can be displayed. We try to display more of these each year.

## EVALUATIONS

The evaluation of this display is intended to show the educational interpretation and developmental appropriateness of original student artwork grades K-12 that meet or exceed NM Arts Standards, Benchmarks and Performance Standards.

## CRITERIA FOR EVALUATION

Criteria for evaluation will include: skill development, understanding of elements and principals of design, composition, inventiveness, commitment, expression, visual sensory perception of the environment, cultural awareness, developmentally appropriate K-12, representation, and demonstration of competency from local, state or national standards.

All entries will receive an exhibitor's ribbon and district certificate of participation.
